Scheduled Appointment Pick-Up/Deliveries:	Kleysen will pick-up and/or deliver within a specific delivery window. Ie. 8 AM to noon or noon to 5 PM. Shipments requiring a specific load/unload time ie. Crane appointment will be subject to additional fee as a percentage of the base load rate. Kleysen does not accept consequential damages due to missed/late appointment times. Steaming:	Railcars requiring steaming to heat product in the railcar will be assessed a steaming fee of \$170.00 per hour with a minimum of 2-hour charge. Railcar must have external heat coils capable of handling a low-pressure steam injection of 15 PSI or less with high volume of water and the material being heated must be predetermined eligible to be heated and safe handling temperatures pre-established. Allotted steam time includes inspection of coils, switching of railcar into and out of position, hooking up and unhooking of steam hoses and actual time with applied steam.	\$175.00/hr, min 2 hours
Flushing Product Pumps / Lines:	Customer request to flush product pump and lines in order to change back and forth between products will be assessed a \$558.00 fee plus disposal of flushing agent and residue product at cost plus 15%.
