D & H Goods:	Dangerous & Hazardous Goods charge per load charged at a percentage of the regular transportation rate plus FSC. Certain classes or packing groups will not be accepted for transportation. Contact your Kleysen representative.	15.0%
Excess Mileage:	Circuitous routing including but not limited to road restrictions, road construction, detours, natural disasters, flooding, fire, and customer direction are subject to additional mileage charges.	\$3.50/mile + fsc

Expedited Service:	When requested, will be quoted on an as required basis.	TBD
Loading:	Rate includes 1 hour loading time. All equipment types.	Included

Cargo Liability:	All shipments are subject to a liability limit of \$2.00 per pound times the weight of the shipment, to a maximum of \$250,000. Shipments having a Declared Value exceeding \$2.00 per pound must be approved in writing by an authorized Kleysen Representative prior to shipment and will be subject to a Cargo Excess Value Charge.

Storage Liability:	As per Standard Warehouseman Policy.	
Payment Terms:	Charges on all balances over 15 days per month.	2.0% per month compounded at 26.8% per annum
Proof of Delivery:	Copies of the bill of lading or other documentation are not provided with invoice. If requested, proof of delivery will be supplied for a fee.	\$30.00 per invoice
Rating of Shipments:	All loads tendered to Kleysen will be rated according to the Rate Agreement. Load tenders or load confirmations will not be used for application of rates to a shipment.	
Fees & Fines:	Kleysen Group will not be responsible for fees, penalties, or fines as a result of delays in transit.
